### SECTION 2. HAZARD(S) IDENTIFICATION:

Hazard Description: pharmaceutically active substance that has not been fully tested

May be harmful if swallowed, inhaled, or absorbed through the skin

Ingestion may result in elevated liver enzymes (ALT/AST), nausea, diarrhea, anorexia (loss of appetite), vomiting, convulsion, pneumonia, interstitial lung disease/pneumonitis, respiratory failure, pneumothorax, dyspnea (shortness of breath), dehydration, hyperglycemia (high blood sugar), gastric hemorrhage, general physical health deterioration, pulmonary tuberculosis, cardiac tamponade, sepsis, prolonged QT interval (heart rhythm disorder), bradycardia (reduced heart rate), neuropathy comprised of paresthesia (sensation of tingling, tickling, prickling, pricking, or burning), asthenia (lack of muscle strength), gait disturbance, peripheral neuropathy, hypoesthesia (reduced sense of touch or sensation), dysesthesia (abnormal sense of touch), peripheral sensory neuropathy, neuralgia, peripheral motor neuropathy, hypotonia (decreased muscle tone), or polyneuropathy, and vision disorder comprised of vision impairment, blurred vision, photopsia (perception of flashing lights), accommodation disorder (inability of the eye to automatically change focus from distance to near objects), presbyopia (diminished ability to focus on near objects), or reduced visual acuity

**SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS:**

**SECTION 4. FIRST-AID MEASURES:**

After Inhalation: If inhaled, remove to fresh air; if breathing is difficult, give oxygen; if breathing stops, give artificial respiration

After skin contact: flush with copious amounts of water; remove contaminated clothing and shoes; call a physician

After eye contact: check for and remove contact lenses; flush with copious amounts of water; assure adequate flushing by separating the eyelids with fingers; call a physician

After swallowing: if swallowed, wash out mouth with copious amounts of water; call a physician

Suitable extinguishing agents: water spray, carbon dioxide, dry chemical powder or foam

Protective equipment: wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes
